\*The Council's Scheme of Members' Allowances includes a paragraph which states: '*If a Councillor does not attend at least two-thirds of the total number of scheduled meetings of the Council, or of the Executive, or of Committees of which he/she is a Member, the Councillor concerned should be invited to pay back an appropriate percentage of his/her Basic Allowance up to a maximum of 25% of the Basic Allowance.*' This applied to one of the above Councillor's during 2017/18 and is reflected in their Basic Allowance payment in 2018/19 and two of the above Councillors in 2018/19 which is also reflected above.
