NOTICE TO APPLICANTS

1. If you knowingly or recklessly make any false statement or omit any material information on this form, you may be prosecuted for an offence and your application may be refused or your licence may be revoked.
2. Tewkesbury Borough Council is under a duty to protect the public funds it administers, and it may use the information you have provided on this form for the prevention and detection of fraud. It may also share this information with other bodies responsible for auditing or administering public funds for these purposes.
3. Tewkesbury Borough Council may share relevant information to other bodies and authorities for prevention or detection of crime, apprehension or prosecution of offenders and assessment or collection of tax, duty or imposition of similar nature.
4. UK Immigration legislation, in particular the Immigration Act 2016, is designed to prevent illegal working in the UK. To prevent illegal working, the authority will carry out necessary document checks on all applicants. These checks are required to ensure applicants demonstrate that they are eligible to work in the UK.

6. Hackney carriage and private hire vehicle drivers (referred to in the Orders as "taxi drivers") have been listed as Regulated Occupations. This means the Rehabilitation of Offenders Act 1974 is no longer applicable when considering the relevance of past convictions of applicants for hackney carriage/private hire vehicle drivers' licences and convictions that would otherwise be considered spent can be taken into account and therefore must be disclosed.
